E. Copy of apartment/home lease agreement stating that utilities are included in lease payment (if applicable-Counts as 2 proofs)

B. Student is living with legal guardian and a certified copy of the Court Decree, or petition if pending, was received declaring the district resident to be the legal guardian of the student and further declaring that the guardianship was formed for a purpose other than establishing residency for school district attendance purposes.

C. Student is living with an adult other than parent or legal guardian and the adult has provided a sworn affidavit stating his/her relationship to the student and that the student will be living in his/her home full time and fully explaining the reasons (other than school attendance zone or district preference) for this arrangement and the School Board or its designee has made the necessary factual determination under 11.1 (c) (2) of the State Residency Verification Procedures.
